The Client shall pay 50% in advance on the signing of this Project Agreement and balance 50% once website homepage design is approved. Invoices will be submitted at the beginning of the project. The fees are payable within 7 days of the submission of the invoice.
- 2. The project will begin from 13 September 2024 and end on 12 December 2024.
- All out of pocket and third party costs, if any like translations, F&B, media events, travel, equipment hire for conferences, printing, etc. will be charged at actual. All such expenses will be incurred after the approval of the client.
- 4. Any Work Order or similar document including but not limited to any code of conduct, policies or registration documents received from the Client shall be for billing reference only and such document shall not take precedence over this Agreement.
- 5. Good and Service Tax and other applicable taxes, if any, will be charged separately in addition to the above mentioned fees and expenses.
- 6. The maximum aggregate liability of Adfactors PR together with its sister concerns, directors, employee, associates or contractor under this Agreement (regardless of the form of action, whether in contract, negligence or otherwise) shall in no event exceed the aggregate amount of fees paid by the Client to Adfactors PR under this Agreement.
- 7. The Client shall at its own cost and expense, indemnify, defend and hold the Adfactors PR, its directors, employee, associates, sister concerns or contractor free and harmless from and against any and all losses, liabilities, claims, actions, costs
